# Terms and Conditions

The following terms and conditions apply to the Refer A Friend Campaign for Eligible Estates which will take place between 30 June 2020 and 25 June 2021 (Campaign Period).

1. **Definitions:** In this document:

<b>Gift Card</b>	means a pre-paid Visa Gift Card for the value of \$500.
<b>Campaign Period</b>	means the period between 30 June 2020 and 25 June 2021.
<b>Introducer</b>	means a person who has purchased a lot from the Promoter at an Eligible Estate and who is not an external sales agent, builder representative or financial planner.
<b>Introduction Form</b>	means the Refer a Friend Introduction Form.
